## **Welcome address**

The President Louis Robert cordially thanked Neeme Rand and all of his team for their warm welcome and for their brilliant organisation of this Conference.

### **1. Adoption of the agenda**

The meeting unanimously adopted the agenda.

### **2. Minutes of the previous meeting (Jesolo Lido, October 18<sup>th</sup> 2007)**

The minutes of the above meeting were unanimously approved as a true record of the proceedings.

### **3. President's Annual Report and Report on Fixed Events (Louis Robert, LR)**

#### **A. Election of a new Vice-President**

Louis Robert announced that the Executive Board had proceeded to the election of a new vice-president following the retirement of Alfonso Benvenuto as stipulated in the statutes. Annie Collinet, director of the Bonneville school, was now his replacement in his role as vice-president in charge of Higher Education and Continuing Professional Development. Rosella Bitti, the new director of the A. Panzini IPSSARCT in Senigallia, automatically became the new AEHT national representative for Italy.

Andrea Cariglia (AEHT member I20) contested this decision, saying that Italy ought to have retained a representative within the Presidium. Louis Robert referred to article 12 of the statutes which states explicitly that *the Executive Board elects a Presidium which consists of 1 President and 5 Vice-Presidents* and that *the President and the 5 Vice-Presidents must be elected from among the members of the Executive Board*. Mr Cariglia openly expressed his dissatisfaction at this decision, even though the decision had been taken in accordance with the statutes

#### **B. Visit to the SENA's Training Centres in Colombia**

LR went on to speak about the study visit to Colombia, during which the Presidium had been the guests of the SENA (Servicio Nacional de Aprendizaje) in Bogotá, which had since the visit been an AEHT member. Contacts between the AEHT and the SENA had been made through the Saint-Quentin-en-Yvelines Hotel and Tourism School in Guyancourt which had been working with the SENA since 2006 as part of an international cooperation agreement.

LR emphasised that the vice-presidents had paid their own travel costs and that all the costs of their stay in Colombia had been covered by the SENA. Sébastien Longhurst, from the SENA's international relations department, gave a short Powerpoint presentation of his organisation.

The SENA is a public training body with branches throughout Colombia, offering free vocational training in all technical branches, with the objective of improving the competitiveness of Colombian companies as well as increasing Colombia's social capital. Courses are available 24 hours a day. Up to 2007 the SENA had already trained five million people (for 2007 alone: 15,964 people in initial vocational training and 193,268 people in continuing professional development). Investment in new information and communication technology and its use have become one of the SENA's priorities. The SENA also contributes to co-financing companies set up by its graduates. It works with training bodies in several countries and has also opened training centres abroad to train expatriate Colombians (for example in Valencia, Spain).

- *The visit to Colombia resulted in several opportunities for cooperation:*

a. SENA's participation in the AEHT Annual Conference

- 1) Participation of four SENA students (culinary arts, pastry, restaurant service and bar) in the Kuressaare conference;
- 2) SENA's search for new partners while at the same time providing information about its key role as a major provider of vocational training in Latin America;
- 3) A Colombian exhibition stand in Kuressaare including displays by tourism promotion bodies and several companies.

b. Student placements

1) Placements for Colombians in Europe

The eight-week placement for SENA students in Saint-Quentin in autumn 2008 would be extended in mid-November by a week's period of observation spent in five European schools which are AEHT members, namely: Coimbra (P), Copenhagen (DK), Diekirch (L), Prague (CZ) and Senigallia (I) in order to provide a European dimension to the placement and to open new cooperation opportunities.

2) Placements for Europeans in Colombia

The visits made by the Presidium to several hotels have opened the possibility of organising professional placements in Colombia for AEHT students. In this context the SENA would provide help with organising the placements and with supporting the young trainees.

### **C. Restolingua**

At the end of the General Assembly the Presidium would sign an agreement with a new professional partner, Restolingua, the developer of a system for translating, editing and printing menus in eight languages including Japanese. The Chinese version is currently under development. The menus can be produced not only in several languages but also using several national currencies. Once translated the menus are saved on the Restolingua server, making them accessible from anywhere in the world. Paul R.A.J. Van den Heuvel and his wife Arike Vermazen gave a demonstration to the meeting of their website [www.restolingua.com](http://www.restolingua.com).

Access to the website would be free of charge until the end of the year, and would then require payment from 2009. For AEHT member schools the charge would be only €500 per year per school (as against €615 for other subscribers). However this charge could be covered by one or more local sponsors, whose logo would appear every time a student or teacher from the school in question logged on to the website. For each new subscriber brought by a school, the school as well as the AEHT would receive a 15% commission on the subscription fee. Member schools were requested to warn their students and teachers that any person who revealed their identification key to a third party would be prosecuted. #### **D. Elections in 2009**

According to the statutes, national representatives and members of the Presidium are currently elected for a period of three years. Louis Robert found that the election procedure involved too much work and that, given the amount of work attached to the roles, these mandates were too short to obtain concrete results. The Executive Board meeting held in Kuressaare had been informed of the problem and had voted in favour of an extension of the mandates to a period of four years. However, only an extraordinary general assembly was empowered to decide on a modification to the statutes. Such an assembly would be called in 2009, and would also make a decision on the possible transfer of the administrative office to another location or even to another country, though without moving the registered head office. This possibility was allowed for under Luxembourg law.

#### **4. Report from the Vice-President for Professional Placements (Bogusława Pienkowska, BP)**

Bogusława Pienkowska reviewed the statistics relating to the observation periods spent in units of the ACCOR group in 2008. Only seven of the 27 places offered by hotels of the group had been taken up. This disappointing figure is largely the result of a job change in mid-year by the placement organiser. Bogusława Pienkowska expressed her regret at the inconvenience this had caused. To avoid a similar situation next year, those involved would begin the organisation of the placements several months earlier than had been the case in 2008.

Gilles Honegger, the former ACCOR group representative, said in a short speech, 'Both sides are running out of steam. After fifteen years we are now in a crucial period'. Behind his words was the message that we needed to pull our socks up in order to avoid an irreversible decline. BP repeated that it was essential to encourage teachers to take advantage of these placements, which are spread over four months from June to September; a list of the participating hotels would be published early in 2009 on the AEHT's website.

## **5. Report of the Vice-President Responsible for Higher Education (Alfonso Benvenuto, AB)**

In this his last report Alfonso Benvenuto, Vice-President responsible for higher education, stated that he would work with his successor Annie Collinet in setting up new initiatives in his area of responsibility, as well as in the area of continuing professional development; in particular he would work on harmonising the lists he had received giving information about schools offering higher education programmes in the relevant area, as well as on a European project of use to everyone, which would have no cost implications for the AEHT: its objective was the creation of a European standard and a model for management and organisation in the areas of quality, food safety, environment and health and safety at work.

## **6. Report from the Vice-President Responsible for Seminars and Occasional Events, and the Publication of Information on National Training Systems and for EU Educational Programmes (Ana Paula Pais, APP)**

### ***a) Events in 2008***

Ana Paula PAIS used a Powerpoint presentation to review the events organised in 2008 under the aegis of the AEHT. A detailed account of the events is published in the AEHT Annual Report available on the website.

Luigi Frati from the 'Einstein-Nebbia' Istituto d'Istruzione Superiore in Loreto (Ancona, Italy) gave a brief presentation of his institution's year-long postgraduate masters degree in gastronomy, delivered in collaboration with famous chefs, as well as of the culinary arts competition which they plan to arrange in March or April 2009.

The 5<sup>th</sup> International 'Antonio Nebbia' Hot Dishes Competition, organised in collaboration with the Macerata Provincial Association of Chefs, would take place on March 22<sup>nd</sup>-25<sup>th</sup> 2009 in Cingoli, Italy. Further details would be available in due course at <http://www.ipssartcingoli.it/> and at <http://www.assocuochimacerata.it> .

As for the 11<sup>th</sup> 'Bartolomeo Scappi' International Competition 2009, scheduled for April 21<sup>st</sup>-24<sup>th</sup> in Castel San Pietro Terme, Italy, a maximum of 20 schools may register and accommodation would be free for all participants.

The 5<sup>th</sup> Competition for Hotel Reception Employees would take place on May 3<sup>rd</sup>-10<sup>th</sup> in Giulianova, and would have as one its themes 'mountain tourism'. Board

and lodging would be free of charge for students; participating schools would need to pay only the travelling expenses. Only students aged between 17 and 19 would be eligible to take part.

Attention was drawn to the 16<sup>th</sup> Christmas in Europe in Château-Chinon on December 5<sup>th</sup>-10<sup>th</sup> 2008 and to the 12<sup>th</sup> edition on December 2<sup>nd</sup>-7<sup>th</sup> 2009 in Poznan (the second time for this venue, the first time having been in 2001). 24 schools would be invited to Poznan. The programme and other information would be published early in 2009 at [www.aeht.eu](http://www.aeht.eu). Christiane Keller took the floor briefly to announce that for the 2008 event 15 schools were registered but that one or two more schools from southern Europe were required and she asked for offers. She used the opportunity to remind the meeting of the fundamental principles of Christmas in Europe: the objective is to 'build bridges' and to enable the participants to share the 'wealth of differences' by for example presenting their countries' ancient Christmas traditions.

The calendar for Christmas in Europe for the next few years was as follows:

- 2008: Château-Chinon, France
- 2009: Poznan, Poland
- 2010: Ponta Delgada, Azores, Portugal
- 2011: Tampere, Finland (to be confirmed)
- 2012: Marseilles, France (to be confirmed)

All organisers of events scheduled for 2009 were requested to send as soon as possible to the AEHT head office all details of the events announced above, as well as all the relevant documents in both English and French which would be published on the AEHT website.

## **6. Report from the Vice-President Responsible for Promotion and for the AEHT Website (Neeme Rand, NR)**

Neeme Rand reminded the meeting of the importance of working e-mail addresses to enable good communication, and he requested those present not only to empty their full e-mail in-boxes, but also to visit the AEHT website and to send him any suggestions for improvement. He paid tribute to the remarkable work carried out by our webmaster Ahti Paju, in setting up the system for online registration at the conference. This new system represents a considerable improvement and will greatly simplify the task of future organisers.

## **7. Financial Report from the Treasurer (Klaus Enengl, KE)**

Rather than spending time over the figures given in the financial statement, Klaus Enengl gave some information about the situation regarding subscriptions: 80 schools had not paid their subscription, and of these 25 had paid nothing for two years or more, thereby risking exclusion. The subscription rate remains at €270.00. The bank transfer charges, which ought to be paid by the member schools, were sometimes deducted from the subscription payable, representing a loss of around €4000 per year for the AEHT. Schools were requested to ensure that they pay these bank charges.

Klaus Enengl then presented the profit and loss table. In 2008 the Luxembourg government had paid its subsidy of €20,000, and would do so again in 2009. The 2008 outgoings were explained by contributions to various events, by salaries and overheads, as well as by travelling expenses and administrative costs. On September 16<sup>th</sup> 2008 the auditors Danièle Snauwaert and Jürgen Clausen had undertaken a check of the accounts and subsequently reported, in a document read out by Klaus Enengl, that the accounts up to December 31<sup>st</sup> 2007 were in perfect order; despite their absence the auditors had agreed to renew their remit for the 2008 financial year, with the approval of the meeting. By acclamation the assembly granted discharge to the treasurer and the Presidium for the 2007 financial year.

Before concluding his presentation Klaus Enengl made a point of thanking the accountant Norbert Richartz, who had taken early retirement from the LTHAH in Diekirch, but who would continue to carry out his accountancy work for the AEHT; he also thanked General Secretary Nadine Schintgen for her conscientious management of the finances.

KE then moved on to read out the lists of new members, exclusions and resignations:

**A) Exclusions:**

The following schools were excluded for having failed to pay their subscription for two or more years and for failing to respond to payment requests which had been sent to them up to four times. The list was longer than usual because no exclusions had been pronounced at the Jesolo Lido General Assembly in order to give the National Representatives time to make contact with those who had not paid.

The meeting approved by acclamation these new membership applications.

Several membership applications from France, Italy, Russia, etc were still being processed.

## **9. Approval of newly nominated honorary members**

The assembly approved the appointment of Alfonso Benvenuto, outgoing director of the A. Panzini IPSSARCT in Senigallia, Italy, as honorary AEHT member, vice-president and president. Louis Robert repeated to Alfonso Benvenuto his best wishes for a happy retirement, and expressed the hope that he would join the work of the Council of Elders.

## **10. Council of Elders**

Adolf Steindl, an honorary AEHT vice-president and a member of the Council of Elders, explained that the Council of Elders had been founded on March 15<sup>th</sup> 2008 in Kuressaare, and that it consisted of former AEHT Presidium members (presidents, vice-presidents, treasurers) who had already been made 'honorary members'. All applications for membership of the Council must be accepted by a relative majority of

the existing members of the Council and must be approved by the Presidium. At present the Council has five members:

Two further applications for membership had just been submitted to the Council of Elders.

The purpose of the Council of Elders was to provide to the AEHT and to its partners such services as:

- Strengthening the AEHT's activities in the area of higher education;
- Helping to identify sponsors;
- Helping to organise and evaluate seminars;
- Representing the Association at certain events in case Presidium members were unable to attend;
- Preparing documents for the publication of a 'commemorative brochure to celebrate the AEHT's 25<sup>th</sup> anniversary, etc.

The Council of Elders would carry out this work without any remuneration. In their quest for funding, the Council of Elders also planned to be self-financing within three years. In addition their travelling expenses were expected to be as modest as possible.

The General Assembly approved by acclamation the setting up of this Council of Elders.

## **11. The Annual Conference and the 2009 Conference in Dubrovnik, Croatia**

- *Conference in Kuressaare*

Apparently problems had been reported in connection with the culinary arts competition which had taken place in Kuressaare. LR said that in order to be taken into account, any complaints should be sent in writing to the AEHT Head Office.

- *22<sup>nd</sup> Annual Conference in Dubrovnik*

The 22<sup>nd</sup> Annual Conference would take place between November 17<sup>th</sup> and 21<sup>st</sup> 2009 in Dubrovnik, a town located at the southern end of the Dalmatian coast, close to the border with Bosnia-Herzegovina and Montenegro. Antun Perušina, the director of the organising school, aided by one of his students in regional dress and by a video presentation, spoke of the charms of our next destination and of Dubrovnik's range of hotels. The participants would probably be accommodated in the Valamar Hotels & Resort. Andrea Cariglia, director of the Vieste school in Italy, expressed the wish to keep the conference in October. Antun Perušina explained that this was not possible because of the Croatian tourist season which lasts until the end of October; thus we had to wait until the low season in order to obtain rooms and advantageous rates. Moreover our schools may wish to attend other conferences (EUHOFA, etc) which take place in

October. In order to resolve this issue LR requested the Assembly to take a vote. The dates proposed – November 17<sup>th</sup>-21<sup>st</sup> 2009 – were agreed by an absolute majority. In conclusion Antun Perušina extended a warm invitation to all those attending the meeting to come to Dubrovnik in 2009.
